### Chapter 33 – Post 9/11 G.I. Bill® at FSU

The Post 9/11 GI Bill provides educational benefits to veterans and veterans' dependents. Tuition and fees for these students, including graduate, medical school and law school students, are covered by this Veterans Affairs (VA) benefit, up to the percentage a veteran is eligible for, which is based on their length of active-duty service since September 11, 2001.

Tuition and fees for students using the Post 9/11 benefit are **paid directly to FSU**. Prior to billing the VA for a student's tuition, the FSU Student Veterans Center deducts any tuition waivers, scholarships, military assistance, etc. that are solely for tuition and have already been applied to the student's account. Financial aid like Florida Prepaid or Bright Futures (or other aid that is not designated solely for tuition) does not preclude the VA from paying for an eligible student's tuition.

"Tuition and fees" includes only the administrative costs associated with courses, not things like housing, meal plans, books, supplies, etc. However, students may receive additional funds to cover those expenses through the Post 9/11 G.I. Bill, including the cost of the mandatory health insurance FSU requires, provided the insurance is purchased through FSU.

- Funds for books and supplies are **paid to the student** by the VA at a set rate per credit hour, up to 24 credit hours per academic year. For VA purposes, an academic year runs from August 1 to July 31.
- If a student makes a change to their course schedule after their course certification has been submitted to the VA by the FSU Student Veterans Center, the student is responsible for paying back the VA any tuition and fees already paid to FSU. Note that after each semester's drop/add deadline, Florida State University will not issue a refund to a student who has dropped a course.
- The VA's [Basic Allowance for Housing \(BAH\)](#) is **paid directly to the student** and may be used in any way the student deems necessary. For on-campus housing, payment arrangements must be made directly with [University Housing](#), although payment deferments (postponed payments) can be submitted through the Student Veterans Center. Note that the VA revises the BAH each January and those revisions take effect the following August.
- The monthly housing allowance may vary by semester since it is determined by the zip code where a majority of a student's learning takes place, whether that is on the main FSU campus (32306), in Innovation Park (32310), the Panama City, Florida, campus (32405), one of the university's satellite campuses, an international (study abroad) site, or the site of any clinical studies, practicums, internships, externships, etc.
- ROTC scholarship awards are deducted prior to the VA being billed for an ROTC student's tuition, unless that student is using the room/board option.
- Students whose financial aid and VA educational benefits have resulted in an over-payment may request a refund through FSU [Student Business Services](#).
- **Out-of-state tuition waivers:** Veterans who physically reside in Florida while enrolled at FSU, including distance-learning students, receive an out-of-state tuition waiver, even if they are residents of another state. Veterans in FSU distance-learning programs who physically reside outside of Florida may also qualify for in-state tuition through the VA Yellow Ribbon Program, provided they are eligible for 100% of Post 9/11 G.I. Bill benefits. Veteran dependents may also qualify for an out-of-state tuition waiver, provided they are using VA educational benefits.
- As a participant in the VA Yellow Ribbon Program, FSU waives 50% of the out-of-state tuition (and the VA pays the remaining 50%) for qualified students who do not reside in Florida and are eligible for 100% of Post 9/11 G.I. Bill benefits. Note that the Yellow Ribbon Program (1) excludes active duty and spouses of active-duty members, (2) holds participating students responsible for any balances not paid by the VA, and (3) FSU's participation is reviewed each year.

**Student veterans and active-duty personnel** must complete the certification process with the FSU Student Veterans Center once they have been accepted to the university and registered for classes. Students using VA educational benefits who have not registered with the VA for those benefits should do so through the VA's [Education and Training website](#).

**Student veterans and active-duty personnel** must complete the forms below to complete the certification process. After these forms have been submitted, an email will be sent by the VA to the student's email address to notify them of what the VA received. The VA will then provide the student with a Certificate of Eligibility/Award Letter at a later date. Once this certificate/letter has been received, **a copy needs to be provided to the FSU Student Veterans Center.**

- [VA Form 22-1990](#), if using benefits for the first time. After submitting this form, the VA will issue a confirmation number, which can be submitted to the Student Veterans Center until the VA Certificate of Eligibility is received.
- [FSU Request for Benefits](#) form – This form must be submitted each semester – after the student's course registration has been completed – along with any additional documents received from the military or VA, which can be scanned and uploaded to the Request for Benefits form or provided directly to the Student Veterans Center by email, fax or in person.

**Dependents of veterans** using VA educational benefits must complete the certification process with the FSU Student Veterans Center once the dependent has been accepted to the university and registered for classes. To begin the process of having their VA educational benefits transferred to their dependent(s), veterans should follow the steps for Transfer of Entitlement (TOE) that are posted to the VA's [Post 9/11 G.I. Bill website](#).

**Dependents of veterans** must complete the forms below to complete the certification process. After these forms have been submitted, an email will be sent by the VA to the student's email address to notify them of what the VA received. The VA will then provide the student with a Certificate of Eligibility/Award Letter at a later date. Once this certificate/letter has been received, **a copy needs to be provided to the FSU Student Veterans Center.**

- [Transfer of Education Benefits \(TEB\) web form](#) – After submitting the form and it has updated to "Approved Status" for the named dependent, a screen shot of the form can be provided to the Student Veterans Center until the VA Certificate of Eligibility is received.
- [VA Form 22-1990e](#), if using benefits for the first time. After submitting this form, the VA will issue a confirmation number, which can be submitted to the Student Veterans Center until the VA Certificate of Eligibility is received
- [FSU Request for Benefits](#) form – This form must be submitted each semester – after the student's course registration has been completed – along with any additional documents received from the military or VA, which can be scanned and uploaded to the Request for Benefits form or provided directly to the Student Veterans Center by email, fax or in person.

### **Requesting deferments (postponing payments)**

Postponing a tuition payment with a veteran deferment temporarily removes the student's tuition liability. Students who have been granted a deferment will, for a short period of time, not have their account placed on "hold" for unpaid tuition. If a deferment is granted on a student's account and, for some reason, the anticipated aid does not arrive, it is the student's responsibility to pay all accounts in full.

Students using Post 9/11 G.I. Bill benefits will automatically receive a deferment once their Request for Benefits form has been processed by the FSU Student Veterans Center. For all other benefits, deferments for tuition, fees and other expenses must be requested:

- For **each semester** a deferment is needed
- No later than the fourth day of classes
- By submitting the online [VA Tuition Deferment form](#)

A request for deferment is **not automatic** – except for Post 9/11 G.I. Bill (Chapter 33) recipients – and separate from the Request for Benefits. Also note that a deferment is not considered to be a payment and, like all tuition that remains unpaid after the tuition-payment deadline, will incur a \$100 late fee. Students are encouraged to check their myFSU Account Statement often in order to avoid any unexpected consequences that may result from a deferment.
